# In scope

These guidelines relate to fee waivers for HDR international students.

# **Fee Waivers and Research Training**

For Research Training programs, Fee Waivers are currently offered in line with the University Fees Policy (INTERIM) (<a href="https://policy.vu.edu.au/document/view.php?id=211&version=2">https://policy.vu.edu.au/document/view.php?id=211&version=2</a>), on the basis that it will bolster the University's strategic aims (Fees Policy (INTERIM) Section 24B).

Fee Waivers arise in several contexts in Higher Degrees by Research:

- International Funding Agency Agreements
- Industry Funded PhD Projects
- VU Scholarships
- Ad hoc fee waiver extensions for international students

The term Fee Waiver is the term used in the University's policies to cover full or partial Fee Waivers – foregoing part or all of a tuition fee for a specified duration. Ad hoc Fee Waivers are *normally* the complete waiving of a fee for a certain number of Semesters, typically one semester at a time. However, when negotiating with international funding agencies Fee Waivers are simply a discounted fee – the fee is not partially waived.

The purpose of providing a Fee Waivers is to secure an Agreement with a sponsor or to secure a completion which would otherwise not be achieved as the student would not have the ability pay the fees.

# **General Principles for Fee Waivers**

The following principles apply to the use of Fee Waivers within VU Research:

- 1. The portfolio of HDR Fee Waivers is managed only on a financially sustainable basis. A maximum annual limit will be set for Fee Waivers to ensure that the overall Fee Waiver support is financially sustainable, within Institutes' and Centres' budgets.
- 2. The PhD projects supported for Fee Waivers must advance Flagship prioritised research, aligning with:
  - 2.1 Research Focus Areas
  - 2.2 Priority and Accreditation FORs (you may find that they are not at the moment)
- 3. Industry partners, who fully fund stipends, are not normally expected to contribute to tuition fees. Usually they are domestic and thus RTP
- 4. Fee Waivers are used as leverage to increase the number of high-quality international students with living stipends.
- 5. Fee Waivers can facilitate timely HDR completions for international students.
- 6. Specific Partnership arrangements done on a case-by-case basis.

# **Externally Funded Scholarships for Students**

#### **International Funding Agency Agreements**

International funding agencies tend to negotiate an overall package for their students studying in Australia. As funders of multiple scholarships, funding agencies typically expect universities to offer their scholarship recipients (and the agencies) value for money. Experience to date has been that sponsors who fund living allowance scholarships for students expect a fee waiver to some extent but not always for the entire period of enrolment.

The main elements of the package that international funding agencies negotiate include:

- Fees including discounts (partial fee waiver)
- Living stipend
- Relocation costs
- Health Insurance
- English language tuition

Fee Waivers (partial or full) offer an avenue to leverage VUR resources in the advancement of our international strategy. Given that they represent a substantial opportunity cost, VUR must be confident that it is offering Fee Waivers in a manner, which maximises their value in terms of the Institutes and Centres, VUR and the University strategy.

Agreements with Funding Agencies need to articulate who will be responsible for covering fees post-maximum duration or at the expiration of the fee support from the sponsor as the sponsor usually does not pay fees at this point in time.

The financial modelling illustrated in Appendix 1 shows that even a very substantial fee discount can still allow the University to cover costs (once RTP funding is taken into account). Likewise, the University currently has a low number of students on international funding agency-sponsored stipends.

#### **Analysis of Opportunity**

Before deciding to enter an agreement with an International Funding Agency, a short business case will be developed by the proponent of the agreement and submitted to the Deputy Vice-Chancellor (Research) for consideration, and will cover:

- Profile of the sponsorship agency and extent of relationship with Victoria University
- Alignment to Research Programmes of the Institutes and Centres
- Value Proposition
- Overall investment
- Quality of students
- Australian competitors' engagement

#### **Industry Partners**

The pool of potential applicants for a project-specific PhD scholarship is often very small. Externally funded stipends will firstly be offered to Domestic students (unless the University is contractually obliged to advertise to international students). Only if it can be demonstrated that there is no domestic demand for a scholarship (normally by advertising a round to domestic students only) will it be advertised to international students.

#### **Proposed Fee Waiver Criteria for International Funding Agencies and Industry Partners**

The following table provides guidance on possible discounts, following the principles listed above.

NOTE: Sponsors meeting more than one criteria may increase the percentage discount. This will be considered on a case-by-case basis; full fee waivers will not be offered.

#### Ad hoc Fee Waivers

Ad hoc Fee Waivers may be required through the business units or Institutes and Centres when a student's sponsorship agreement has expired and they have not yet submitted their thesis for examination. These Ad hoc Fee Waivers are provided in an effort to ensure completion. With a student so far into their program, the best way to ensure completion has been thought to be by maintaining continuity of enrolment until submission (and entitlement to a visa to remain in Australia) for international students. These Ad hoc Fee Waivers are normally awarded for one semester at a time where there are compelling reasons for the waiver to be applied – for instance the student proceeding through the milestones in reasonable time and preparing good quality work.

#### **Ad hoc Fee Waiver Applications Criteria**

Given that the aim of an ad hoc fee waiver is to maximise their chance of a completion, Fee Waivers should primarily be applied where there is a strong likelihood of timely completion, for instance by ensuring fees apply for extensions. Fee waivers should only be offered to the extent that avoiding the need for an extension was within the student's control

Therefore, it is recommended that the following criteria should be applied for Ad hoc Fee Waivers, balancing opportunity with an increasing (financial) pressure to complete on time:

<sup>\* \$4,800</sup> is based on supervision cost for 1 semester (academic with \$175kpa salary (inc HR on-costs) plus 30% infrastructure on-cost). It is assumed at this late stage that a student would have completed project-related spending and only need supervision.

#### **Current Policy for Fee Waivers**

important that the current Fee Waiver sections in the Fee Policy to note (https://policy.vu.edu.au/document/view.php?id=211&version=2) are geared towards overall coursework programs rather than research programs. These are mainly framed for undergraduate students for whom the revenue is attached to enrolment numbers and where Fee Waivers are granted on welfare grounds. The HDR environment is different as revenue is attached to completion of candidature. In addition, usually HDR students seek an extension for reasons other than welfare related matters.

Currently, Fee Waivers are granted by the Director Student Wellbeing at the University. VUR is not following this process. An amendment to these policies will be required in order to accommodate the VU Research recommendations made in this document.

# **Administration, Management and Approval of Fee Waivers**

It is recommended that Research Institutes and Centres Deputy Directors have the authority to approve Ad hoc Fee Waivers for HDR students. Responsibility for approving individual fee waivers for the categories in the following table can be delegated in writing to the Institute Deputy-Director.

#### **Budget**

The Institute and Center Executive Directors will offer fee waivers within the constraints of their annual budget, for fee waivers, which will take into consideration HDR student load and position industry funded scholarships.

# **Financial Analysis**

A major income source for the University's research training programs is the Commonwealth government's Research Training Program (RTP) block grant. In 2018, this was worth \$7.5m. The RTP is calculated using two performance components measured over 2 years, each weighted 50%: <a href="https://docs.org/lengths.com/html/">HDR completions</a> and research income. Technically, this means that completions generate 50% of the \$7.5m and the following financial analyses are calculated on this basis. However, it is important to stress that the entire \$7.5m depends on University having a HDR program.

In light of this, it is also worth reiterating that the down side of discounting fees in order to achieve the principle aim of attracting stipends for HDR students is low. Even a fee discount of 70% would still provide a profit for all degree types (including RTP income) except low cost masters, for which a small loss of \$1693 would be incurred if Victoria University also offered insurance and ESL training.

For selected students (see Table 2 in main document) a fee of \$4,800 can be offered, since this will cover supervision and other direct costs will not be required. This still provides a substantial disincentive to continue beyond the timely completion date.

#### **Definition**

<u>Scholarship:</u> Funding to support students degree which pays for both living allowance and tuition fee.

Fee Waiver: VU provides an exemption of student fees payment which means that there is no cash flow to VU.

#### **Comments**

- Seven current tuition fee waiver agreements; two agreements are pending to be finalised;
- This list does not include scholarship agreements.
- Based on the seven current agreements, VUR has a total of 26 fee waiver places. This figure does not include the two Indonesian agreements (see table) where the number of spots are not specified in the agreement.
- In 2017, there were a total of seven fee waiver research students enrolled at VU and in 2018, two tuition fee waiver students (till 8th May 2018). These figures relate to the agreements included in this document only.
- In 2017, VUR provided four international scholarships (RTPs). Number for 2018 are yet to be determined.
- Among the above, the China CSC agreement appears to be the one that has generated more students, followed by Vietnam International Education Development.



# **Competitors Current Fee Waivers**

#### **Background**

A brief Google search was conducted on universities in Australia regarding tuition fee scholarships offered to international HDR students<sup>1</sup>. The result shows that with exception from Deakin University, most investigated universities provide full tuition fee waiver (100%) for international HDR students who meet their eligibility and selection criteria.

Universities refer to tuition fee waiver differently. For example, the University of Melbourne uses "fee remission" and "fee waivers" interchangeably. Monash University uses "tuition fee sponsorship". La Trobe University calls it "full fee research scholarships" or "feerelief scholarship". Deakin University calls it "25% of student contributions (tuition fees)". These terms are quoted interchangeably in this document.

In summary, in addition to the Australian Government's Research Training Program (RTP), there are different schemes of <u>tuition fee, stipend or full scholarships</u><sup>2</sup> in different universities. The public information about these schemes suggests that if a tuition fee scholarship is offered, either as a standalone scholarship or a part of a full scholarship, it covers the full duration of the HDR degree, with or without extension opportunities.

The tuition fee scholarships or full scholarships that cover tuition fees offered by ANU and Swinburne are detailed in Table 1. Brief information on HDR scholarships at the other universities is provided in Table 2.

In Table 2, Column A presents a full scholarship or stipend the only scholarship offered at different universities. Most scholarships cover tuition fees for the duration of the course (three years/four years for PhD or one/two years for Masters). Column B includes scholarships that only cover tuition fees for the duration of the HDR courses. Generally, they are awarded together with a stipend scholarship.

All tuition fee scholarships included in Table 2 cover the full duration of the courses. Except for Deakin University, all listed universities provide 100% tuition fee waiver.

# **Policy Change Procedure**

The table below presents all steps that are involved in changing a police at Victoria University. Key roles and responsibilities include:

- Policy Owner (VU Business Unit): Manages policy development, review and maintenance.
  Identifies areas requiring policy change or creation in consultation with Manager, Policy and
  Compliance Services, with advice from Legal Services. Authorises and oversees the policy brief for
  policy development. Seeks advice from relevant bodies/authorities on developed policy and seeks
  approval from the relevant Policy Maker. Implements approved policy. Reviews policy need and
  content every 3 years or earlier if required.
- Policy Advisor (VU Business Unit): Drafts policy brief to capture an identified need for policy change or creation. Drafts the proposed policy in consultation with the Manager, Policy and Compliance Services. Provides ongoing direction and input to the Manager, Policy and Compliance Services throughout the development of a policy. Assesses feedback received on developed policy and makes suggestions on required changes to the Manager, Policy and Compliance Services. Drafts and manages any procedures that support a policy. Ensures the currency of any procedures that support a policy.
- Manager, Policy and Compliance Services (Office of the Vice-Chancellor): Manages the policy development process. Manages overall policy scope and quality. Reviews submitted policy brief, determines, in consultation with Legal Services, whether the identified need is best met by policy and makes a recommendation to the Policy Advisor on how to proceed. Provides policy drafting support to Policy Advisor as appropriate, considering strategic priorities and resourcing. Conducts consultation on developed policy and makes required changes after considering feedback. Communicates approved policy to the University community. Determines whether a policy change is minor or substantive.
