Before you enrol

First, here are a few things you'll need to complete your enrolment. Taking a few minutes to get yourself ready now will make it easier once you get started.

What you'll need

◆ Your student ID number

You can find this in your official course offer email.
(Can't find this? [Get in touch with us.](#))

◆ Your Unique Student Identifier (USI)

To get your USI (or check if you already have one) head to the Australian Government's [USI website](#) and follow the instructions.

◆ Your Tax File Number (TFN)

You can get this from the [Australian Taxation Office website](#). (You'll need your TFN if you're applying for financial support, such as a HELP loan.)

◆ Your course delivery plan

This is an important document that gives you information about your course structure, requirements and what units (subjects) you can study. [Find your course delivery plan here.](#)



Have you accepted your course offer?

Before you can enrol, you'll need to officially **accept your offer**.

To do this, click the link in your official offer email and follow the instructions.



Your tech set-up

◆ Multi-factor authentication (MFA)

To log in to our VU student hub, you'll need to have an MFA app like **Microsoft Authenticator** installed on your phone. This gives your account and personal information an extra layer of security.

◆ Use Google Chrome for the best experience

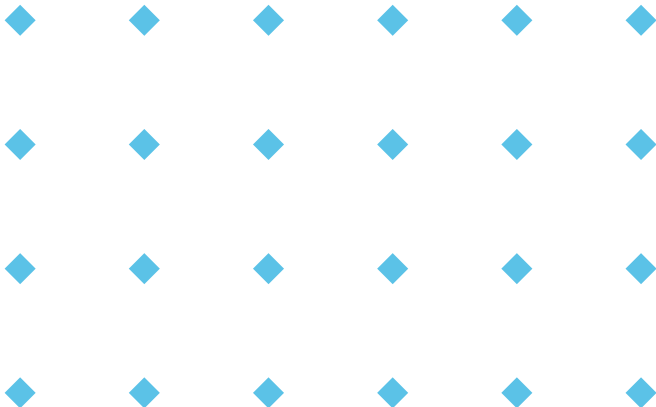
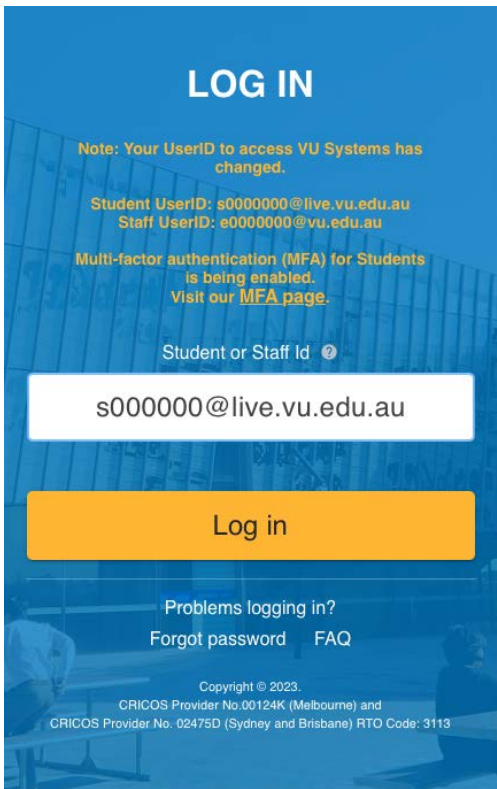

Log in

Go to myvu.edu.au and log in with your details below.



2 Get your password reset link

Now it's time to change your password to something only you know.

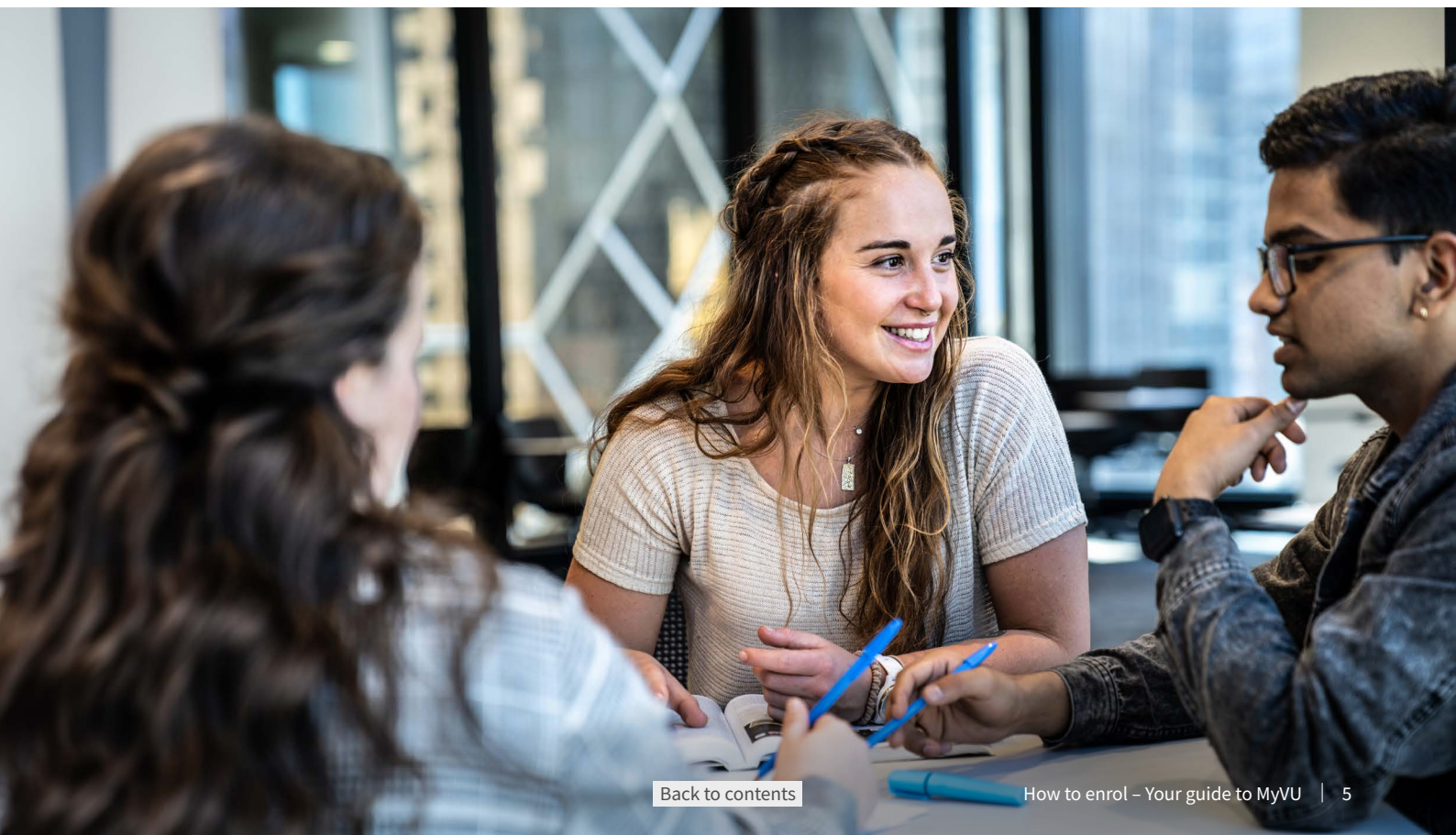

To get a password reset link, type in your personal email address and a mobile number, and click continue.



3 Change your password

Type in your current (temporary) password, followed by your new password, and confirm.

Click on '**Change password**' to go to MyVU.

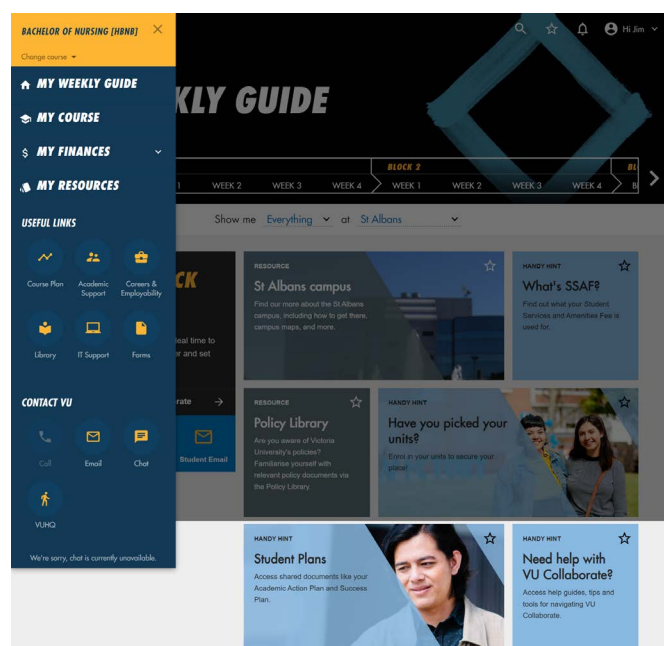
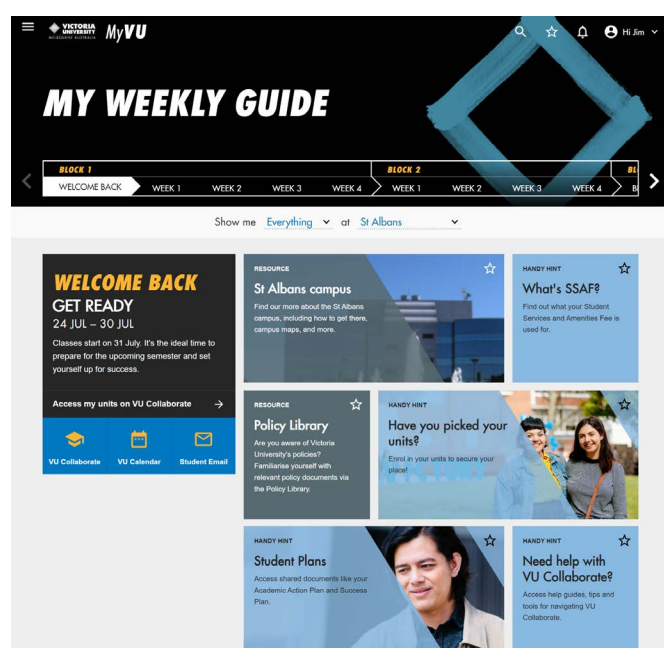


Start your enrolment

Now that you've logged in and changed your password, you should see your personalised welcome page.

From here, go to your enrolment page

- ◆ Click the menu on the top left hand side of your screen, and click on 'MY COURSE'.
- ◆ You should now see your course and enrolment info.
- ◆ Click 'ENROL NOW'.



Help and tips

- ◆ Are all your details (name, course) correct on your welcome page? If anything isn't right, contact VUHQ by clicking on the question mark in the top right corner of the screen.
- ◆ If you have multiple course offers, you will need to use the unique link in your offer email to enrol in the course you wish to study.
- ◆ You will see a 'home base' campus listed. This is the main VU campus where you will study.

Read and accept the student privacy notice and declaration

- ◆ Click the check box to confirm that you have read and accepted this.
- ◆ Then click the **'Start'** button at the bottom of the screen.



Track your enrolment progress

You can track your enrolment process by looking at the navigation bar to the right of the screen.

You can click on this at any time to go back to a previous step.

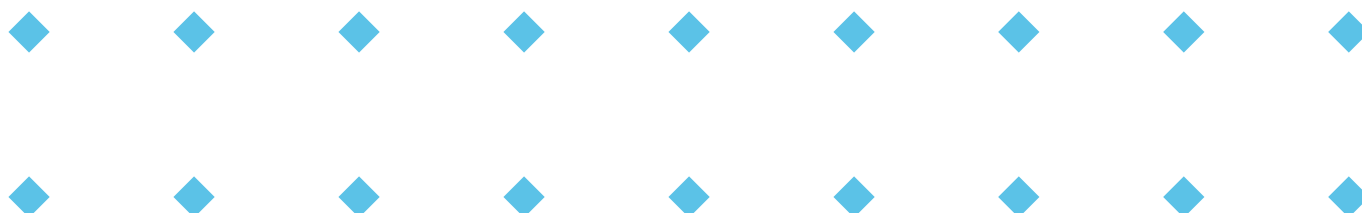

Unique Student Identification (USI)

Your **Unique Student Identification (USI)** is an Australian Government ID number used for any TAFE or uni study you do in Australia throughout your life.

To get your USI (or find it, if you already have one), visit usi.gov.au

USI DETAILS

Unique Student Identifier (USI)

The USI (Unique Student Identifier) is a ten digit identification number that is required for domestic and international students studying a recognised qualification in Australia. The USI must be provided at the time of enrolment as it's a mandatory government requirement.

* **Please ensure you use the same name in which you enrolled at VU.** For example, if you enrolled as 'Jane Marie Smith', please make sure to use this same name when you apply for your USI. If you did not use a middle name and enrolled as 'Jane Smith', use that name for your USI.

Alternatively, if your legal name has changed and you are applying for a USI under your new name, ensure that you [update your personal details](#) at Victoria University using the Personal detail amendment form before you submit the USI. [Contact us](#) if you need assistance.

Financial support

If you are eligible for financial support from the Australian Government through a **Commonwealth Supported Place (CSP)** and/or a **HELP loan**, the relevant form will display here. This will depend on your citizenship status, and the course offer you have accepted.



What is a Commonwealth Supported Place (CSP)?

If you have been offered a CSP place in your course, this means the Australian Government will pay some of your fees, and you pay the rest.

This remaining cost is called your 'student contribution amount.'

What is a HELP loan?

There are different HELP loans available, depending on your citizenship status and the course offer you have accepted.

- ◆ **HECS-HELP** can be used to pay your student contribution amount if you have a CSP place.
- ◆ **FEE-HELP** can be used to pay your fees if you do **not** have CSP place.
- ◆ **SA-HELP** can be used to pay your student services and amenities fee (SSAF).

Commonwealth supported places (CSP) & HECS-HELP loan

You are eligible for a Commonwealth Supported Place (CSP) and HECS-HELP Loan.

To accept your CSP and apply for a HECS-HELP Loan you will need a Tax File Number (TFN) and valid Unique Student Identifier (USI) which must be submitted via the Australian Government Electronic Commonwealth Assistance Form (eCAF) system by your first enrolled **course date**.



If you have been offered a FEE-HELP loan

What happens next?

It's important to know that you will still need to submit another form to the Australian Government.

When you click ‘Submit’, this sends a request to the government to contact you with your next steps.

Keep an eye on your email inbox for **an important email from the Australian government**, with a link and instructions to complete your online Commonwealth Assistance form (eCAF).

You should receive this email within 48 hours.

In the meantime, you can continue your VU enrolment!

Choose your major and minor

If your course requires you to choose a major and minor, you can select this here.

- ◆ **A major** is a subject area you will specialise in during your degree. For example, in a business degree you can choose a major such as marketing or accounting. At VU, a major is made up of 96 credit points (equivalent to 8 units).
- ◆ **A minor** is a subject area that will be the second focus of your degree. At VU, a minor is made up of 48 credit points (equivalent to 4 units).

Click on **'Select option'** to see available majors and minors, and choose.

Full time students: To complete your course within the expected course duration you are encouraged to enrol in 48CP per semester.

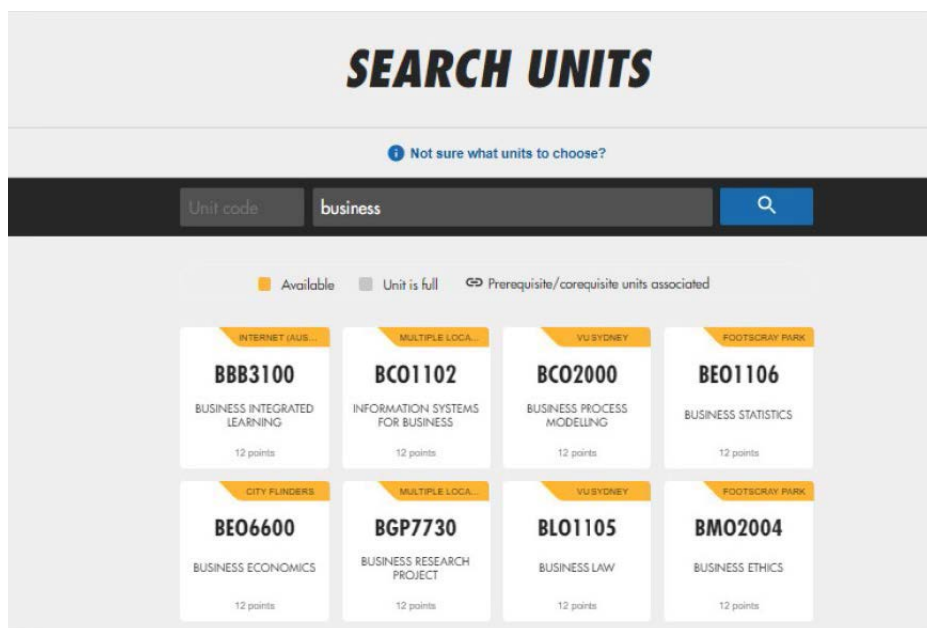
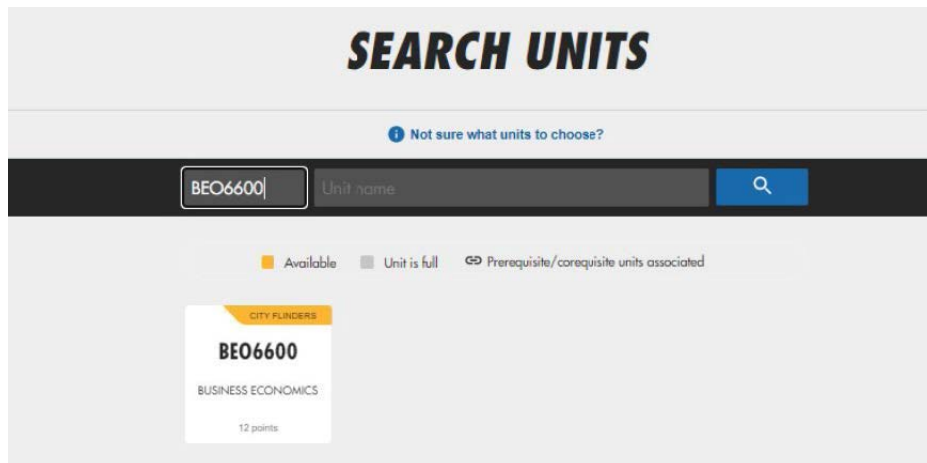

Add units

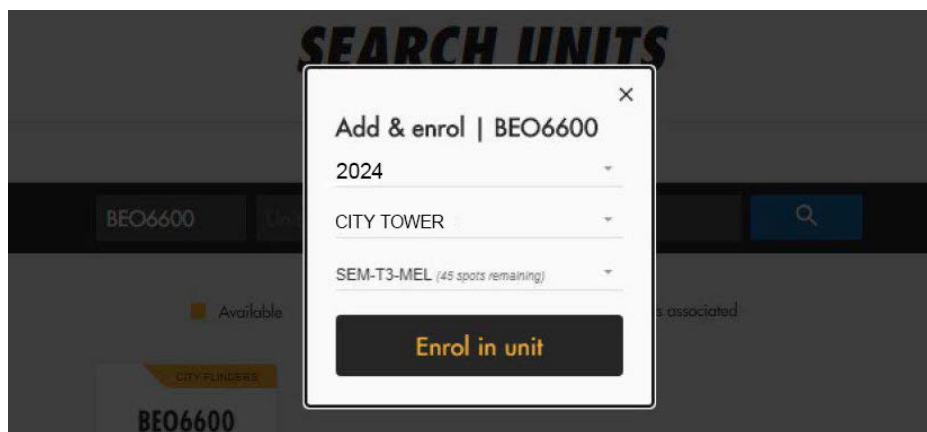
To find units available to you, click on **'Add units'**, then use the search bar at the top of the page to search by unit code or name.

If you don't know the full unit code or name, you can type in a portion of it. This will find all units with the search term in it.



To add the unit, hover over the tile and click **'Add'**.

Select the campus and study period from the displayed options, then click **'Enrol in unit'**.

To see more information about the unit, click on 'Unit details'. This will take you to the full unit description on the VU website.



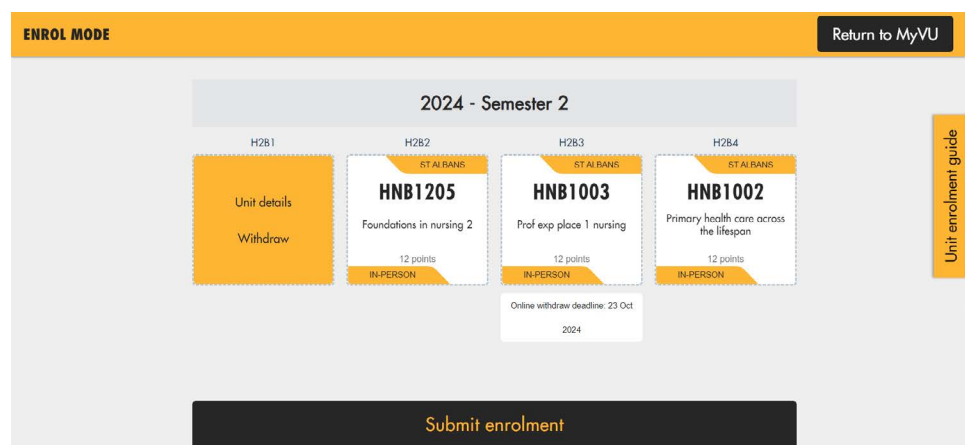
Remove units

Get your student ID card

Your student ID card gives you access to student discounts, services and more. To get your ID card, follow the instructions to [submit your photo online](#).

Check or change your timetable

To check your timetable, go to MyVU, then VU Calendar, and then My Timetable.

Here you can:

- ◆ browse the available class times for the units you're enrolled in
- ◆ specify your time preferences for when you'd like to attend
- ◆ change your allocated times after preferences have been sorted (subject to availability)
- ◆ check the location of your lectures and tutorials.

Check your fees

When you enrol in your course, any fees you need to pay will be outlined in your Statement of Account (invoice). You can check your invoice through MyVU.

Make sure you pay your fees before the relevant **Census date** to avoid any financial penalty.
