Eligibility and fee information for students

The Skills First program provides eligible students access to government subsidies which means you can access a reduced tuition fee. You will need to prove your eligibility for a Skills First Funded place as part of the application process. Further details regarding the amount of subsidy you will receive towards your course will be included in your Statement of Fees which will be provided to you with your offer. If you are not eligible for a Government subsidised place, you will be charged the full-fee tuition fee for all enrolled hours.

Free TAFE Initiative

Eligible government subsidised students will not pay course tuition fees in selected courses as a way of reducing the financial barriers for students wanting to train in courses that have been identified by the State Government as the occupations that are most needed by employers in the Victorian economy. Material fees

The material fees provided in this schedule for each course includes only those materials provided to you and excludes any materials you may have to purchase in addition to this. Details of any materials you will be required to purchase will be provided to you in the Statement of Fees with your offer.

Paying your fees

You must pay your tuition fees by the due date indicated on your Statement of Account/Invoice, which can be accessed via MyVU. Payment options available include:

- For eligible students enrolling in a Certificate IV or below course OR for eligible students enrolling into a Diploma or above course where the course is not on the approved VET Student Loans course list or the student is ineligible to access a VET Student Loan:
 - a payment plan where you are able to pay your tuition fees, material fees and SSAF in instalments, or
- For eligible students enrolling in a Diploma or above course that is listed on the approved VET Student Loans course list and the student is eligible to access a VET Student Loan:
 - a payment plan where you are able to pay your material fees and SSAF in instalments, and/or
 - a VET Student Loan for eligible students who commenced their course.

Concession - If you are accessing a Skills First funded place, a Government concession may be available to you provided you meet additional eligibility criteria. If this criteria is met, you will be charged the concession rate which is equivalent to 20% of the tuition fee. Note concession rate is only available on the Student Services and Amenities fee and the tuition fee, it does not apply to materials fees. Further, you cannot apply for a concession if you are enrolling into a course as a full-fee or international student.

Aboriginal Access Fee Waiver - Students who are of Aboriginal or Torres Strait Islander descent who are eligible for Skills First Funding are entitled to a tuition fee waiver. SSAF and materials fees are still payable by the student.

Asylum Seeker VET Program - eligible students that are enrolled under the Asylum Seeker VET Program are charged the concession rate for Skills First funded training up to Certificate IV level.

Recognition of Prior Learning / Credit Transfer - Recognition of Prior Learning for a unit(s) within the enrolled course will be charged at the standard tuition fee rate for Skills First funded students and at 50% of the standard tuition fee rate for full-fee students. Credit Transfers are free of charge for both Skills First funded and full-fee students.

Withdrawal / Refund - If you wish to cease or take a break from your studies, you must formally withdraw from your course by signing a TAFE Withdrawal Form. If you do not formally withdraw by the withdrawal date, you will still be liable for all fees. Please contact your teacher or teaching area Manager to discuss and complete your withdrawal. Student Services and Amenities Fee (SSAF)

The SSAF contributes to the provision of improved services and amenities of a non-academic nature to all students at Victoria University. The SSAF for vocational education students is charged at the rate per enrolled hour up to a maximum value as indicated below each calendar. The amount you are charged depends on the number of hours you are enrolled into and whether you are eligible for a concession. The SSAF must be paid upfront upon enrolment. Approved SSAF charges for 2025 are listed below and may be subject to change.
