Introduction

The purpose of this document is to provide information to candidates who are interested in applying for appointment as a member of the Victoria University (VU) Disability Governance Committee.

This recruitment process is for an External Independent member who identifies as having a disability, as outlined in the position description.

This information should be read together with the [position description](#) and [recruitment brochure](#).

Application process

How and where to apply

To apply, your application should be submitted electronically via the govsec.nominations@vu.edu.au inbox (external link). Please ensure your submission includes:

- covering letter addressing each selection criteria, with a maximum of 120 words for each criterion
- resumé no longer than 5 pages
- contact details for two referees (email and phone number), and
- [declaration of private interests](#).

Accessibility

We are committed to an accessible and inclusive recruitment process. If you require an adjustment, or assistance participating in any stage of the process, please contact Governance and Secretariat at govsec.nominations@vu.edu.au. You only need to provide information relevant to the support or adjustment you are requesting.

We invite you to tell us if you identify as Aboriginal or Torres Strait Islander, a person living with disability, from a culturally or linguistically diverse background, LGBTIQ+ or a young person, under 25 years old. We would welcome the opportunity to contact you and discuss how we can support you through the recruitment process.

Confidentiality and privacy

The selection process and all matters relating to it are strictly confidential. All personal information received will be handled in accordance with the *Privacy and Data Collection Act 2014*.

How long does the process take?

Applications open on 28 August 2026 and close midnight 10 September 2026.

Shortlisting and interviews are expected to take place after the position closes in September 2026.

What should I include in my application?

You are required to complete a [Declaration of Private Interest](#) (external link) form as part of the application process and will be requested to complete additional probity forms if shortlisted and appointed. The following information should also be provided:

- a copy of your resumé, no longer than 5 pages
- a covering letter, no longer than 2 pages
- contact details for two referees.

The covering letter should **clearly** detail how your skills, knowledge, and lived and professional experience are relevant to the Selection Criteria in the [Position Description](#) (external link).

All applicants must address the *Selection Criteria* set out in the Position Description, including the criteria applicable to all Committee members and the specific skills and experience sought for this appointment. Your resumé should identify your current employment, occupation and relevant unpaid or voluntary roles, where applicable.

Declaration of conflicts of interest

It is important that applicants clearly identify any conflicts of interest which may arise if appointed to the Disability Governance Committee and specify how these conflicts will be managed.

Members are required to complete a [Declaration of Management of Private Interests](#) (external link) form to disclose any pecuniary interests or other interests that could conflict with the proper performance of their duties and/or potentially present a significant risk to the operation of the University.

What happens once I have applied?

Shortlisting and interviews

All applications are reviewed and assessed against the requirements for the role.

Shortlisted applicants are invited to attend an interview.

Safety screening and probity checks

Appointment is subject to the satisfactory completion of safety screening and probity checks, specifically:

- an Australian Securities and Investments Commission (ASIC) disqualification register check
- a National Personal Insolvency Index check through the Australian Financial Security Authority
- a national criminal records history check.

If you have lived overseas for more than one year in the last ten years you will also be subject to an international police check.

If you are shortlisted, we will send details regarding the screening and probity checks.

When will I know the outcome of my application?

All applicants will be contacted by email as soon as possible once an outcome has been reached.

If you are recommended for appointment, you will be formally advised and informed of the timeline regarding final determination.

- ☐ **Cover letter** which addresses the selection criteria (max. 120 per criteria)
- ☐ **Resumé** that includes:
 - ☐ your full name and address
 - ☐ your phone number and email address
 - ☐ your employment and/or volunteering history
 - ☐ your education history
 - ☐ information about past or current membership of any bodies (for example, board or committee memberships).
- ☐ **Contact details for two referees** which includes:
 - ☐ full name
 - ☐ relationship to you
 - ☐ phone number
 - ☐ email address.
- ☐ **Declaration of Management of Private Interests** that is completed and signed

It is the applicant's responsibility to check their application has been satisfactorily completed and all the required documents have been provided.
