Please note that this information will be used for guidance on subsequent development of our doctoral candidates. The specific information provided by you will be restricted to the candidate, the candidate's supervisor, the Chair of Examiners.

### PART ONE: THESIS / MAJOR WORK QUALITY

Please use the following guidelines to evaluate the quality of the thesis against each aspect in Table 1.

#### Guidelines for Assessment of Thesis / Major Work Quality

Score	Quality	Description
1	Exceptional	Such a contribution will be of the highest merit, and in the examiner's opinion indicate that the doctoral work is at the forefront of investigative endeavour in the field. We consider that it is likely that only 10% of doctoral theses would contain material that would merit this score.
2	Excellent	Such a contribution would be considered to be a meritorious effort in the field, and be the basis for a significant publication. Somewhere between 10% and 30% of doctorates would contain material that would merit this score.
3	Very Good	A 'Very Good' level would imply an interesting, sound and compelling treatment of the particular aspect of the thesis. Elements of the issue would be well presented and logically argued. A large number of theses, perhaps between 30% and 60% of those submitted would contain material that would merit this score.
4	Good	A 'Good' contribution of a particular aspect to a thesis / major work is one that is sound overall, but is not compelling in some respects. Such contributions would not be expected to have the impact of similar work that has been assessed at a higher level. Perhaps between 10% and 30% of theses would contain material that would merit this score.
5	Adequate	This level would represent an area of work that might conform to the usual conventions of doctoral research but whose contributions are of limited value. A small number of doctorates, perhaps only 10% would contain sections that merit this score.
6	Poor	A 'Poor' assessment of aspects of work appearing in a thesis / major work will represent, in the examiner's opinion, contributions to the study that only just meet the requirements for inclusion in a doctoral thesis. Whilst the formal conventions of a doctorate should clearly be present for the thesis / major work to be graded as 'Passed', it might at times be evident that minimal scholarship has been involved in aspects of its construction. It is considered that a very small number of theses, perhaps less than 2%, will contain material that will merit this score.

Aspects of the thesis / major work	Score (1 – 6)
The <i>intellectual concept</i> behind the thesis, which traditionally represents a substantial and original contribution to knowledge to the subject area with which it deals;	
The <i>Literature Review</i> , which contains an indication of the candidate's familiarity with the field, their ability to understand and synthesise complex ideas, and demonstrates an appropriate application of the literature to the candidate's study;	
The <i>breadth of the study</i> , which for a doctoral thesis / major work should be sufficiently comprehensive to develop an original contribution to the area, but be focused enough to provide significant depth of treatment of relevant concepts;	
The <i>methods and methodology</i> , which should be appropriate to the subject matter and applied in a scholarly and effective manner;	
The <i>presentation of the results</i> , which should be clear, concise and accompanied by expository text accessible to the reader;	
The <i>presentation</i> of the entire thesis, which should be written in English of an appropriate academic register and of a format and standard of presentation acceptable to the area of study;
